# APPEAL FORM INSTRUCTIONS

#### I. FORM OF COMPLAINT:

An ethics complaint appeal must be written and submitted on this form.

#### II. SIGNATURE AND DELIVERY:

Appeals MUST be signed to be valid. If filing anonymously, only the Appeals Committee will know the Appellant's identity. See below.

- Appeals must be delivered to the USAWE Appeals Committee.
- Existence of the appeal must not be communicated to any other person who is not involved in the investigation of the appeal.
- Include only one appeal per form.
- Appeals must be accompanied by a fee of \$100. The appeal fee will be refunded if any part of the claim is considered valid.

## **CONFIDENTIALITY REQUIREMENT**

All written complaint appeals, conversations, documents, or other activities involving an alleged ethics violation appeal are confidential and shall not be revealed in any manner to anyone except those Association members charged with the responsibility of investigating said appeal and the Respondent (person the complaint is filed against). Therefore you may not disclose the fact that you filed this appeal and may not discuss its contents with anyone other than those involved in the investigative process. Only the Respondent and those involved in the investigative process will be provided with the information contained in this appeal.
