US RULES FOR WORKING EQUITATION

• **eBlast – WE Trials** – BOD approved DRAFT communication

Rationale: As of 3/1/23, there are currently 97 show license requests; of which 19 are holding cattle trials. The Executive Committee and the Directors are aware there has been mis-communication regarding the prescribed order of Working Equitation trials. We are unsure which shows received incorrect information and there are licensed shows and a zone championship show that listed the trials out of order. BOD recommends sending an e-Blast to membership (not just show organizers) to communicate the prescribed trial order, the cattle trial is not a separate license and is not a separate event and ask each organizer to review their show premium, entry form and social media announcements.
