President Elect Doreen Atkinson called the meeting to order at 5:00 PM Pacific time.

AFFILIATE ORGANIZATIONS (AO) – Kristine Strasburger reordered the <u>Affiliate Organizations</u> on website; each with their own page. Held Quarterly AO Networking Hour Monday April 24 with AO Leaders that featured an informal informative presentation on working cattle without cattle. Check out the <u>AO Resources</u> on the usawe.org website. AOs are growing steady (average 1 new AO per month); currently 59 recognized affiliate organizations. Plan to add committee members by the end of year.

AWARDS – Bridgett Klingler reported all 2022 year-end awards are distributed. Planning on a survey to 2022 award recipients. Plan to have 2023 awards and budget ready by end of 3rd Quarter. Committee is working smoothly. Ask show managers to ensure rider-horses are members and recorded; otherwise, it slows down post show result reporting. How are we allowing non-members to compete? Is there a non-member policy? Non-members can request a one-time show voucher. Membership Chair marks vouchers as Expired after the show date passes and marks voucher if member joined.

COACHES NETWORK – Absent.

COMPETITIONS – Two new member added to committee and committee is up-to-speed. Able to fill slots based on set criteria for committee duties and posted a help wanted FB post on USAWE.

ELECTIONS – Biddie Lowry has no updates. Sufficiently staffed.

ETHICS - Dan Dahlke, all quiet.

FINANCIAL OVERSIGHT – Brittney Flowers working on policies/procedures. Follow up on ETA of tax return preparation so Board has 10 day review before submission.

HORSE RECORDINGS – Absent.

INTERNATIONAL COMPETITION TASK FORCE – Doreen Atkinkson reported there are (2) youth interested in USAWE Team TryOut for the Youth/Young Rider WAWE Competition. Deadline June 15. Committee is discussing fundraising efforts. Estimated cost is \$15-20K. Rider must be at L6 minimum. Columbia is working on hosting an 'Americas Competition' in Columbia later this year.

LICENSED OFFICIALS (LOC) – Christy Reich shared two items: LOC has EOH Seminar coming up mid-June in Woodstock IL. LO attendance is good; weak on membership participants. Asked if R5 Director and AOs in the area could promote and participate. Seminar Information and Registration is posted on the home page of the website. L5-L7 Travel Grant is available for rider-horse pairs interested in being considered for International Team. LOC is working on committee policies/procedures with committee member criteria. Volunteer help needed (cannot be LO, per Bylaws, as both of those positions are filled). Quite a few LO candidates in the pipeline.

MARKETING AND PROMOTION – Karen Boso unable to attend but provided the following emailed update: Dressage Illustrated Handbooks should be ready to ship shortly. Novice Book should be approved to ship 4/26/23. Dressage Illustrated has orders for the Novice book already. Advanced book is in review. Logo wear store up and running. I just received my order and product looks great. More items to be added going forward. Flyer ready to print - QR code currently points to website home page. Will be changed to unique landing page once that is ready. Three Trade Show Grant applications submitted and approved thus far. New Banners ready for print. Youth Committee Chair sitting in on Sunday's Marketing meeting to discuss promotion ideas. Doreen Atkinson reported a WE demo at Devon, PA (Sept 26-Oct 1) and podcast is planned.

MEMBERSHIP – Kate Steffes reported the committee now has 5 members and share the workload. 893 members as of 4/26/23. Is a lifetime membership being considered? Kate reported there are a few multi-year members (thru 2026). Looking to see what can be automated.

RULES – Jeanne Bond indicate no update.

WEBSITE – Kristine Strasburger reported testing the new word 'Search' feature. Currently in a trial period. Please try it out, provide feedback and report any issues to webabmin@usawe.org. Recommended a subject index search.

YOUTH DEVELOPMENT – Kasey Riddle reported added new committee members and now a committee of (8) that includes (1) youth member. Held first meeting; planning a budget, brainstorming ideas (contests, fundraising, grants, social media account for youth) and committee policies/procedures. Identified major issue is youth rider show expenses. Established a 'Youth Development Fund'. Communication (fliers) with 4-H, Pony Clubs and Lesson Barns that tie in WE Coach and Licensed Officials. Considering a Youth Only Extravaganza Show. Youth Championship Show Scholarship program has \$6700. Recruitment...Training...Retainment. Is it possible to consider donating \$ from annual membership to youth?

President Elect Doreen Atkinson adjourned the meeting at 6:34 PM Pacific Time.
