RUSINESS

- Treasurer Transition Update Newly appointed Treasurer, Leesa Nero is working with previous Treasurer
 Erin O'Shaughnessy on transitioning bookkeeping and working with President Stanko in obtaining access to bank accounts.
- 2023 Budget appreciation to Kris Blacklock, Secretary and Leesa Nero, Treasurer in gathering historic data, itemizing committee expenses to date and creating a draft budget based on actual income/expense plus proposed committee requested budgets. This extensive work provided the board and committee chairs with a 'big picture' view of the organization's financial fitness.

This Executive Session meeting intent was to track income/expenses based on history; review the income and expenditures on the excel spreadsheet. Data will then be uploaded and tracked in QuickBooks.

- Annual vs. Actual draft budget based on historical income/expense and actual income/expense provided by committee chairs/members.

- Budget Review Treasurer Leesa Nero walked through the Draft 2023 USAWE Budget vs. Actual figures
- O Q&A held after budget review
- Financial Reporting Treasurer asked what information was needed by the Executive Committee and Committee Chairs to monitor organizations' financial status. It was recommended financial reporting be broken out by corporate and specific committee income/expense.
- Chart of Accounts Categories (Pros and Cons) Committee chairs to provide treasurer with a list of income/expense classifications by committees (profit/loss) via an email to Treasurer@usawe.org
- Expenditures for remaining 6 months in 2023 (approved and proposed) and projected for 2024 –
 Committee chairs asked to review budget/expenditures to see where to cut back in 2023
- Income for remaining 6 months in 2023 and projected for 2024 Committee chairs to identify income revenue for 2023 and 2024

Budget Planning Options:

- Base committee expenses on a value proposition budget
- Identify 'What are the goals of our mission statement?' Then, 'How do we fund those goals?'
