ELECTIONS – 2023 ELECTION– by Biddie Lowry, Chair

Rationale: To ensure transparency and to streamline the annual election process, contract the 2023 election with the online *Simply Voting* vendor used in the past three elections. Per BOD policy, expenses \geq \$500 require Board of Directors approval.





Elections are held in November of each year for Officer and Director positions according to the following schedule:

Odd-numbered Years	President Elect, At-Large Director 1, Regional Directors 1, 3, 5, 7	
Even-numbered Years	President Elect, Secretary, At-Large Director 2, Regional Directors 2, 4, 6	

The Treasurer position is appointed annually (not an elected position).

Individual U.S. Adult members of USAWE who have met the deadline for membership established by the Board of Directors are eligible to be nominated and vote in USAWE elections.

ELECTIONS – CANDIDATE STATEMENTS – by Kristine Strasburger, Website Chair and Biddie Lowry, Elections Chair

Rationale: Establish a standardized format for candidate statements in order to provide a side-by-side assessment of candidate experience, qualifications, and plans.

1. Members do not have a good way to assess BOD candidates and their qualifications or suitability for BOD service with the current way we are requesting candidate statements.





2. Candidates will be able to have more confidence that they are providing the right kind of information in their candidate statements if we have a clearer outline of what they should submit.

USAWE DONATION BUTTON – Biddie Lowry, Elections Chair and Kristine Strasburger, Website Chair

Rationale: During the 7.26.23 Committees Working Session, Elections Committee Chair Biddie Lowry recommended placing a donation button on the <u>usawe.org</u> website on multiple pages (i.e. Home page, footer navigation, etc.) to encourage organization general fund donations. Idea was also vetted with Kristine Strasburger, Website Committee Chair, Leesa Nero, Treasurer and Brittney Flowers, Financial Oversight Committee Chair.

Per Kristine Strasburger "we use a single donation payment processing page and then use a drop-down to select which fund people donate to. We already had the youth program as a donation option. We only need to add the additional selection option."

Motion is based on USAWE CPA Becky Alexander email response to query regarding donated funds (not restricting specific purpose).

Q) USAWE is discussing adding a "donation" button to our website. As a non-profit can we use any donated funds for anything we want or must they go to special efforts like education, grants, or scholarships? If so, anything else they can be marked for?

A) "Donations to nonprofits are, by default, unrestricted, meaning you can do whatever you want with them, including spending them on administrative expenses. That is unless the donor specifically requests that you spend





the money on something specific, such as scholarships or education. In addition, if you were to put "Donate here to support scholarships" or something like that, I would consider money raised there to be restricted to the purpose you stated on the button."




