7/19/2023 BOD	ROD	Starting with the 2024 membership year, begin implementing membership dues for youth riders, (not to exceed adult annual dues)
	800	and those dues allocated specifically for youth programs and opportunities designated by the Youth Development Committee.

Rationale: Based on recent surveys of parents and to support youth grants, youth scholarships, and other youth programs; a membership fee of \$45 will be collected with the sole purpose to be placed into the Youth Development Fund. This fund directly contributes, distributes and supports all current and future youth programs, scholarships and grants. Public communication of youth membership fees directly going back to the youth will be immediate in collaboration with membership and marketing in an effort to transition this change to our members.

*A discount for multi-youth and families was considered, however it was determined at this time it was best with accounting and membership to have a fee per person to avoid confusion and mistakes.

WAWE 'S' JUDGE LICENSED OFFICIALS TRAINING – TRAVEL – requested by Christy Reich, Licensed Officials Committee Co-Chair

Rationale: For the first time in USAWE history, WAWE has requested that we present our top judges to attend their training in Spain this September. They have requested judges from all WAWE member countries with the goal of having at least one WAWE judge per country. We are honored to present USAWE 'S' Judges, Doreen Atkinson, Nicole Chastain-Price, and Polly Limond. Rebecca Algar is not able to attend.

The LOC requests that USAWE reimburse a portion of the costs associated with our (3) S Judges traveling to Spain for education, testing, and possible licensing from WAWE.

Their attendance will benefit the organization in the following ways:

- The more education that we have directly from WAWE ensures that we correctly emulate the judging guidelines and ideals as set by WAWE.
- The S Judges are an integral part of the LOC programming by reviewing our educational output and assisting with teaching, and defining and triaging what subjects we need to focus on.
- Our S Judges will have the opportunity to continue to educate and refine their judge's eye, by
 receiving education and immediately viewing top rides at the Spanish National
 Championships.
- With this important education, our judges help our members by providing feedback that is consistent from judge to judge.
- This education trickles down to our R, r, and L judges via webinars, being shadowed, scribed for, and teaching members in clinics.
- Our upper-level riders, who have aspirations to represent the US internationally, are greatly benefited when they compete under judges who have been educated and have seen in person where the WAWE licensed judges have set the bar.

We respectfully request that each attendee be reimbursed \$500 to cover a portion of the airfare to attend the WAWE Judges Training in Ciudad Rodrigo, Spain, September 13 - 17, 2023. We estimate that the entire cost of the trip and cost of the training/testing to be \$2,250 per person. To receive the \$500 reimbursement, each attendee must submit a receipt of their airfare.
