**SECTION 14. DECISIONS BY MAIL OR EMAIL** Any decision that the Board of Directors may make at a meeting may be made without a meeting if the decision can be made and approved by U.S. mail or electronic means via email or some other electronic method, by the affirmative vote of all of the members of the Board. A clearly stated motion must be sent to all of the Directors on the Board by U.S. mail, email or some other electronic means with clear instructions that this process requires 100% (one hundred percent) of the Directors to vote "yes" for the motion to pass. If the motion is sent by email or some other electronic method, then each Director must send their vote by that same method in reply, in which case no signature is necessary. **CORPORATE – PRIVACY POLICY - MEMBERSHIP DATA –** requested by Kris Blacklock, Secretary and Kate Steffes, Membership Chair

**Rationale:** As Secretary, I've been contacted by a few members as to what we do with the membership information obtained, so for transparency and compliance with a <u>Colorado Privacy Act</u> that became effective July 1st, 2023 that includes nonprofits (of which USA Working Equitation is a Colorado based nonprofit organization), recommend adding a privacy statement to our website, membership request form and Policies and Procedures.

On July 7, 2021, Governor Polis signed Senate Bill 21-190: Protect Personal Data Privacy establishing the Colorado Privacy Act (CPA). The CPA tasked the Colorado Attorney General with implementing and enforcing the CPA, including adopting new rules. The CPA is a part of the State of Colorado's Consumer Protection Act and goes into effect July 1, 2023.

The CPA grants Colorado Consumers new rights with respect to their personal data, including the right to access, delete, and correct their personal data as well as the right to opt out of the sale of their personal data or its use for targeted advertising or certain kinds of profiling. The CPA also places new obligations on covered entities to safeguard personal data, including the requirement to give Coloradans meaningful information about the collection and use of their data, to conduct data protection assessments, and to obtain consent before processing certain sensitive personal data.

Recommend adding a privacy statement to our website Membership Info page, Membership Request Form and Policies and Procedures (see below) to notify our membership how we use their membership data.
