Past Issues

- Effective January 1, 2024, raise the Show Licensing Fee to \$4 per horse/rider pair competing in each USAWE licensed competition that uses GIRA. Retain the \$5 per horse/rider pair competing in each USAWE licensed competition that does not use GIRA.
- Appoint **Morgan Osbaldeston** (R7-GA) as a reporter and member of the Marketing and Promotion Committee, effective immediately.

Executive Session – October 5

- To define and identify in Policies and Procedures which committees are Board Committees
 (authorized to act on behalf of the board and require public notice, agendas and minutes) and
 committees that are considered operating Working Committees (not authorized to make decisions
 without board approval).
- Authorize the distribution of an eBlast and Social Media posts for committees seeking volunteers.

Board of Directors Meeting – October 11

- Effective January 1, 2024, remove the option for non-members to compete at USAWE-licensed competitions. Non-members will still be allowed to ride "schooling rides" at regular (non-championship) licensed competitions but can no longer compete without joining USAWE.
- Effective January 1, 2023, change the Regional Leaderboard awards to honor the top two horse/rider pairs in each rider division (Open, Amateur, Youth) and Level (L1-L7) in each region (R1-R7), rather than the top three, as the organization has done since its founding.
- Effective January 1, 2024, change the name of the recognition given to the top two National and Regional Leaderboard horse/rider pairs at each level (L1-L7) and in each rider division (Open, Amateur, Youth) from "National or Regional #1" and "National or Regional #2" to "National Leaderboard Champion [level] [division]", "National Leaderboard Reserve Champion [level] [division]" and "Regional Leaderboard Champion [level] [division]", "Regional Leaderboard Reserve Champion [level] [division]".
- Authorize increasing the Adult membership fee to \$55 beginning with the 2024 membership year.
- Distribute an eBlast membership campaign and accept next year's memberships starting
 December 1^{st.}
- Appoint Virginia Aulin (R1-ID) as a reporter and member of the Marketing and Promotion Committee, effective immediately.
- Authorize implementing a Youth membership fee of \$41 beginning with the 2024 membership year.
- Authorize replacing the term 'Junior' with 'Youth' (age 7-17 years) in all aspects within the
 organization (i.e., Awards, Competitions, GIRA, Membership, Rules, Policies & Procedures,
 website, etc.), effective January 1, 2024.

GET TO KNOW A RECOGNIZED USAWE COACH

Kimberlee Barker - Corvallis, Oregon

What inspires you to be a Working Equitation Coach?

The fun challenge of teaching riders how to take their horses up the levels delights me. I love that magic moment of discovery when a student develops clear communication and harmony with their horse.

What is your favorite obstacle? Why?

The bull line. I love the finesse needed to elegantly pick up the spear and ring and the trust and confidence your horse needs to approach the bull. And honestly, it's fun to ride around with a spear!

Practice, practice! Make your horse so comfortable and confident at home that pressure in competitions does not overwhelm you. Remember to breathe! Remember to smile! Remember this is FUN!

What's your favorite trick for remembering WE courses?

I memorize the obstacles by number in a list first. Then I create "stories" after the course walk like "head for the hills" to remember to exit away from the judge, or "open the gate to the bridge."

Your all time favorite WE horse?

Oxidado: my original WE crush! Now Mafalda Galiza Mendes & Isco, and of course my own kind, generous horses rank high on my list too, especially Minuet & Gladheart Black Harris, my Masters partners.

What would your students say is your catchphrase?

"When in doubt, just ride better!" It breaks tension & helps us realize we can be our own worst enemies—we forget to breathe, we forget to ride, and mostly we forget to sit back and enjoy the ride!

What non-equestrian activities do you love to do?

I enjoy camping, exploring, and photographing deserts like Death Valley, Escalante, and Goblin Valley with my husband. Bicycling, sailing, and kayaking are up there too!


USAWE Election Begins November 1st!

The election of the 2024 USAWE Board members is right around the corner! USAWE uses an independent company called Simply Voting to conduct the election. U.S. Adult members will be able to vote anytime from November 1st to November 15th.

Here is a bit of information on how this process works.

First, the candidates' names and statements have been posted on the USAWE website as of October 15th. Please read about your candidates so you can make an informed decision. On November 1st, you will receive an email from Simply Voting.

Here is a sample email from Simply Voting:



- The Elector ID is your USAWE membership number.
- The password will be generated by Simply Voting.
- Follow the link to go to the voting website, log in with your Elector ID and password given to you in the email. You will then see the ballot.

This year, everyone will vote for President-Elect and At Large Director 1.

Regions 1, 3, 5, 7 will also see a question to vote on the candidates for their regions only.

Each year, \$5 of your annual membership dues was earmarked as Member Designated Funds (MDF).

The final question will give you an opportunity to determine the destination of your MDF. Your choices will

On August 11th, the Board of Directors appointed a Quality Assurance team tasked with identifying and resolving licensed show scoring/placement/show result issues, soliciting GIRA.io user feedback and seeking software enhancements/apps that streamline the process from start to finish. The QA Audit identifies what works well, makes suggestions for improvement and suggests ideas to enhance functionality.

<u>Click Here</u> for a recap of the GIRA.io Feedback Survey results. Survey conducted August 11 – September 15, 2023 with 134 Show Organizers, Managers, Scorers and Licensed Officials (Judges and TDs); 34 respondents, a 25% response rate.

Zone Championship Wrap-Up

Since the last newsletter, USAWE has held three successful Zone Championships. The Eastern Zone Championship, with 37 horse/rider pairs competing, was held September 22-24 at the Diamond 7 Ranch and Arena, Dillsburg, PA. The Central Zone Championship, which took place September 29 - October 1 at the Walworth County Fairgrounds, Elkhorn, WI, also welcomed 37 horse/rider pairs -- 11 of them youth. Finally, the Western Zone Championship had 32 horse/rider pairs compete at the Big Sky Horse Park, Missoula, MT.

All three championships welcomed L1-L5 competitors, and those attending the Western Zone Championship had the opportunity to watch a Masters Level competitor as well. The cattle trial proved quite popular, with a total of 42 horse/rider pairs entering across the three competitions. At the Eastern Zones, 4 out of 10 horse/rider pairs successfully penned their cattle; at the Central Zones, 11 of 15 horse/rider pairs penned their cattle, and at the Western Zones, 9 of 17 horse/rider pairs penned their cattle.

Participation at these large in-person championships helps USAWE members get to know others participating in the sport from across the country. The opportunity for making new friends from outside their local show area is one of the highlights of the championships. The Competitions Committee would like to thank the organizers and the many volunteers who made these events possible. Kudos to all involved for a job well done!

2024 Changes:

There will be a small change in the competition fees charged to USAWE licensed show organizers. Starting with the 2024 show season, The fees will increase from \$2 per horse/rider entry to \$4 per horse/rider entry when the GIRA scoring system is used. The Licensed shows not using GIRA will remain @ \$5 per horse/rider entry competing in a USAWE licensed show.

Starting with the 2024 show season, non USAWE members will no longer be able to compete in USAWE licensed shows. Non-members may ride as "Schooling Rides" only in any non-championship licensed shows.





The Youth Development Committee has been busy creating opportunities for the youth in our organization. 11 scholarships were awarded this year allowing these teams to attend CHAMPIONSHIPS!

Speaking of opportunities... All of the membership and the youth were asked (all Summer) to design ideas for an USAWE Youth Logo. There have been three finalists selected for this contest! Please keep a lookout in November for a MEMBERSHIP VOTE for the FINAL logo selection! YOUR VOTE COUNTS! This logo will be used for awards, logo wear as well as to represent the youth!

An official announcement (in this newsletter first!) is that the USA Board of Directors, with support; has voted that there will be a membership fee beginning 2024 for youth. You may initially be disappointed hearing this, but let me personally assure you that ALL of this money is 100% going back to the youth that can be applied for! As a mother of TWO YOUTH members, I never would have let this pass if it was not a benefit for the youth of this organization!

This membership fee will keep the Championship Scholarship Fund ongoing as well as the Youth Development Fund and future grant opportunities we are developing.

In 2023, a youth member could apply for \$425 (Central Zone) to attend a championship show and ALL QUALIFIED applicants were awarded the Championship Scholarship.

The **NEW** Youth membership fee in 2024 is \$41 per applicant, so essentially your YOUTH can join, apply (if we can keep this program alive and develop new programs) and attend functions; and they may be COMPLETELY PAID FOR by the membership fees! We also have programs in motion for grants, fundraisers and discounts for youth.

WAWE INTERNATIONAL JUDGE'S SEMINAR AT THE SPAINISH NATIONAL CHAMPIONSHIPS

This is a recap of my experience of my time in Spain for the WAWE judges testing. But first, I would like to thank USAWE Board of Directors, Licensed Officials Committee fellow, competitors and members for your support in attending this seminar. The time I spent in Ciudad Rodrigo, during my tryout to be a WAWE judging candidate, was a great treat. Jose Benito and Merchy Ruiz were the best hosts starting with a tour around the city, which, by the way, is a walled city. You could see the moat all the way around the historic city and see vantage points to look over the hill with cannons pointing out in case of an attack. It even had a castle which was turned into a nice hotel. This town is one of the towns that has the running of the bulls down the streets chasing many runners. I saw the list of bulls being picked for each town that would participate in this run. The history and culture there truly depicts Spain. The people are genuinely nice, social and excepting of our non-Spanish speaking group. One area I had to get used to was the times for meals. They close the restaurants for lunch by four and they do not open again till 8 PM. I guess that's for the siesta. The Iberian meat, which are usually wild pigs that eat acorns, was the most popular meat. I still chose steak and grilled cheese sandwiches. The Spanish culture and riding style using the garrocha was evident with many statues around town and pictures in some of the bars and restaurants. My fellow candidates were Polly Limond and Nicole Chastain Price from the USA, others from Belgian, Italy, the Netherlands, Australia, Poland and one from Czech Republic. We became fast friends and traded many stories and experiences.

This was a <u>testing</u> seminar, not a <u>teaching</u> seminar. Candidates were expected to know the material beforehand. There were written tests, as well as video and live shadow judging. The written test was on theory and technical movements, e.g., completely describe walk rhythm, half pass, leg yield, pirouette, side pass and how to perform specific obstacles; etc. True/False questions covering WAWE rules were in the test as well. Then came silent Video judging on score sheets. We had no time to prepare or review. It was Handled as if in real time. There was no time to second guess the marks we gave because we turned in the tests immediately – no time to go back and look at them. We had to be quick on collectives and quick on comments. (A scribe would have been helpful but was not allowed.)

We scored six dressage tests, and our scores had to be within 4% of the examiners score. And it was the same thing with EOH. We watched 6 rides to judge. Then we judged videos out loud. Scores were entered in a computer and compared to the WAWE judges scores. Claudia Matos, from Portugal, was our examiner, and she drilled us with questions, as if we were being asked by a reporter. She watched as we handled pressure with questions fired at us, and how confident we were in our answers. This testing definitely was a stressful setting but used by the examiners to assess our ability to work under pressure. Saturday was the live judging portion of the testing and unfortunately the weather started to turn bad with rain and wind so we only watched the Dressage phase before they canceled the rest of the day. That

held with each candidate went over 'this is where you are weak, this is where you are good'. Sunday was not raining, but it was very windy and cold. We watch the EOH and speed phase. The cattle phase was canceled due to a contagious cattle disease that had broken out that month.

Claudia watched everything:

- Tested on how you handled pressure
- Tested on how you handled people
- Tested If you were a team player

This was also taken into consideration of each candidate:

- Personality
- Knowledge
- Professional image

My advice is for candidates to be confident, competent, assertive, and able to work under pressure. This is a sport for the field horse so judge/train it as that – a useful working horse. Understand the criteria for each movement/obstacle. Know the Quality of the gaits and the basic training which is #1. What is a good walk? Canter? Be able to identify quality. Which is good and why. What is the 'why' behind the quality. Must be able to technically explain why a gait is good or not good. The quality of the gait and the training, balance, connection and collection is more important than the precision of the figure. One must be able to defend your marks. Use judge's terminology in comments. Know terminology of basics. Be able to answer why you gave a mark. If a candidate passed this testing exam, the next step is to silent/shadow judge two international shows within 2 years with scores within the 4% range or attend another one of the testing seminars.

More Tips for future candidates:

- · Know the rules in advance
- Train your eye to the basics, collection and connection.
- Study movements. How would you rate this horse, and why?
- · Participate in calibration sessions
- Take USDF L Program basics
- Bring a scribe to the testing seminar if possible
- Listen. Talk doesn't mean anything you're assessed on how you perform.
