BOARD OF DIRECTOR MOTIONS

Agendas and Minutes of all Executive Committee and Board of Directors meetings are posted on the usawe.org website > Corporate > Records > Meeting Minutes. Below are decisions since the BOD e-Votes November 19, 2023.

Decisions by Board Meeting - November 29, 2023

- · Announce to the membership the roll-out of the Regional Championship Show structure now, for a 2025 start including Regional, Multi-Regional Championships, and a National Championship show. The 2024 Zone Championship Show structure will remain in effect as per our Competitions Manual and website for 2024.
- Change to the 2024 qualifying period for Championship Shows. Rescind the 11/21/2022 Board of Directors (BOD) approved motion "For competition year 2023, at least one of the scores must be earned during the current competition year. The qualifying period is January 1 of the previous competition year through the show entry deadline for the zone championship in the current year. Beginning in the competition year 2024, both scores must be earned during the current competition year." and replace with: At least one of the scores must be earned during the current competition year. Starting in 2024, the second score may be earned in the current competition year or may be carried over from the immediate previous competition year. Both scores must be earned within the specific performance level.
- Starting in 2025 when Regional Championships will be held, qualified horse/rider pairs can only compete in the region's championships in which qualified scores are earned. Riders can show at any regional championship show outside their "home" region as long as they have earned qualifying scores in that region. Horse/rider pairs may show in multi-regional championship shows if they have earned qualifying scores in the multiple regions. That means if a rider wants to show in 2 different regional championship shows, they must earn 4 total qualifying scores. (2 from each
- In 2024, Board of Directors (BOD) approved Zone Championships will continue to receive a USAWE \$2,000 grant as previously approved (per Competitions Policies and Procedures, Competition Manual and usawe.org website Championships page).

Starting in 2025, Board of Directors (BOD) approved Regional or Multi-Regional Championship Shows will receive \$1,000 grant money per region. If a multi-regional show is put on, then the show will get \$1,000 per region involved in the show (i.e., If 2 regions are putting it on, the multi-region show will receive a \$2,000 championship show grant).

- The Championship Evaluation Committee (CEC) for Regional or Multi-Regional Championships must be comprised of:
 - A competitions committee member not residing in that region(s).
 - o One At-large Director.
 - o Regional Director(s) from the region(s) involved in the bid proposal.
- CEC will follow a bid proposal process. All proposals require board approval.
- The Regional Director must serve on the Regional Championship Show Committee in their region in an advisory capacity after the show has been approved. This role is to act as a liaison between the regional members, show organizer and the Championship Evaluation Committee (CEC) to ensure that all parties, including the regional membership understand the process, show requirements, as well as show details.
- Approve the 2024 Western Zone Championship proposal submitted by the organizing committee headed by show manager Kristine Strasburger, to be held September 18 – 22, 2024 at the Oregon Horse Center in Eugene OR.
- Re-appoint Mary Duffy (R2-CA) to the Competitions Committee, effective immediately.



Licensed shows:

The 2023 Season has completed its last show of 2023. What a great year! USA Working Equitation licensed or provisionally licensed 141 shows; 119 shows were held. A few shows were canceled due to Vesicular Stomatitis in CA.

2024 is out of the gate! We already have 41 shows on the calendar for 2024! Be sure to go to the usawwe.org > Competitions Resources page to review the Competitions Manual and submit a show licensing application request form.

Championship shows:

There were also 3 Zone Championships held in 2023 (Eastern, Central and Western), and they were all a fantastic success. So, Kudos to all those that stepped up to help make these shows a success.

2023 will be the last year for Zone championships. REGION 1

December in the Pacific Northwest is dark and wet. I dream of warmer climates and the upcoming year. With working equitation's rich history and cross-cultural opportunities, my dreaming often turns to Portugal. Will this be the year to go? The Feira Nacional do Cavalo in Golega, Portugal, occurs in November and, with the event just in the rear-view mirror, I checked in with four Region 1 members who made the trip. I asked each what stood out and how the journey impacted them. The trip was a first for Kenton Wright (Open, L7 rider) and his son, Maverick "Pavito" Wright (Junior, L4 rider). Kent noted that "the sheer volume of quality horses make one's heart start beating faster." They had a wonderful time meeting tons of horses and many kind and helpful people along the way. He feels future trips will be different because of the impactful relationships they developed. The trip changed how he will train and set goals in working equitation because the level of talent and quality of work that he saw in Portugal raised the bar to a level of excellence that seems to be almost commonplace in Portugal. He came away focusing even more on a light connection and building that harmonious presentation we all strive for. His goals revolve around creating movements with smaller aids and plans to integrate more frequent repetitions of work than he had previously done. Pavito most enjoyed experiencing the culture and the quality of horses. For future trips, he would like to visit more stud farms, see more horses, and go to a bull fight. He also came away with new approaches to his riding and says he now spends more focused time working on the walk and has a new appreciation for walk-canter-walk transitions.

The trip was a second visit for Kimberlee Barker (Open, L7 rider) and Emily Callihan (Amateur, L2 rider). Kimberlee first commented on the quality of riders—from 8-year-olds to 80-year-olds—at the Feira. But I took four pages of notes on her descriptions of the Lusitano horses and the development of horses in Portugal. In summary, she said the horses were remarkably generous and kind. Despite producing many upper-level horses, she was amazed by the almost magical ability of trainers/owners to develop super confident, willing, soft, flexible horses. She was humbled by the generosity of the horses, and she wants to return asap. Emily's focus was on the Feira and the incredibly supportive crowds that turn out for EOH and speed phases—standing room only, several people deep from the rail. Portugal's young riders and the women who dominate their WE divisions were inspirational and have her seeking more grace and precision in her own riding. Whether one's goal is experiencing Portuguese culture, drooling over horses that are the product of hundreds of years of selective horse breeding, or studying to improve one's own riding, the main takeaway appears to be that one trip will not be enough!
