3. Shadow an "R", "S", or WAWE Judge

A minimum of 50 **Dressage** and 50 **EOH** rides at two licensed shows is required. A ride is defined as an individual **Dressage or EOH trial entered and ridden by a horse/rider pair at a licensed competition**. Disqualifications are included in the count; scratches and withdrawals do not count. Rides must be with at least two different "R", "S", or WAWE Judges. Specific requirements include:

- Level 4: 5 rides (Dressage and EOH)
- Level 5: 5 rides (Dressage and EOH)
- Level 6: 1 ride (Dressage and EOH)
- Level 7: 1 ride (Dressage and EOH)

4. Judging/ Co-Judging Experience

A minimum of 150 **Dressage** and 150 **EOH** rides at licensed competitions within the 2 preceding years is required. Judging requirements may be met by **silent judging** or co-judging licensed shows with an "S" Judge. **The Judge's written evaluation and score comparisons are required (Judging Assessment Form) for each silent judging or co-judging event.** Specific requirements include:

- Level 4: 15 rides (Dressage and EOH)
- Level 5: 15 rides (Dressage and EOH)
