AT-LARGE DIRECTOR 2 VACANCY

Resignation of Stephaine Hayes, At-Large Director 2 - resignation notice dated 8/14/2024, received 11:45 PM by President Doreen Atkinson via USAWE corporate email.

In accordance with Bylaws of *USA Working Equitation, Article V Full Board of Directors, Section 4. Election of Directors and Terms, F. Vacancies,* members of the board were asked if any director was interested in the filling the remaining term (through 11.20.2024) of the At-Large Director 2 vacancy.

Two (2) Regional Directors expressed interest: **Kiki Pantaze**, Region 4 Director and **Cera Olson**, Region 6 Director. Each candidate submitted (and read) a Candidate Statement for the board to review, interview and vote at 8.14.24 Executive Session. Board asked each candidate questions regarding their involvement in working equitation, relevant work experience and accomplishment goals for the remaining term of At-Large Director 2.

At 7:31 PM Central, both Cera Olson and Kiki Pantaze left the meeting (placed in Zoom waiting room) for board vote.

Zoom Poll Vote was conducted during the Executive Session; 9 votes total: **Cera Olson** = 5 votes; **Kiki Pantaze** = 4 votes.

At 7:38 PM Central, both Cera Olson and Kiki Pantaze were readmitted to the board meeting.
